• Former owner is requesting a refund for a payment that they made after they sold the property.

The Board approved of refunding the erroneous payment back to the previous homeowner and write off the loss to bad debt.

iii. Request #3

• A number of homeowners have raised concerns regarding snowplowing in front of the CBU mailboxes. It would be appropriate for the Board to consider adding this to the snowplow maintenance contract at this time.

The Board will request that Architerra clear the snowplow in front of the mailboxes on an as needed basis.
